The Bill of Complaint of John W. Boyer and Mary E. Boyer  
his wife, respectfully shows unto your Honor:-

1st.

That Greenberry Boyer, late of Frederick County, deceased, de-  
parted this life on or about the twenty-first day of February,  
eighteen hundred and ninety six; that the said Greenberry  
died intestate and at the time of his death was seized  
and possessed of a lot or parcel of ground situate in the  
Village of Suptown, Frederick County, Maryland, being the  
same lot or parcel of ground conveyed unto the said  
Greenberry Boyer by John T. Lewis and Evaline Lewis,  
his wife, by deed April 23rd, 1881, and recorded in Liber  
N. F. No. 4, folio 31v., one of the Land Records of Frederick  
County; a Certified Copy of which said deed is herewith  
filed as Exhibit No. 1, and which, together with all other  
exhibits hereinafter produced, it is prayed may be taken  
and considered as part of this Bill of Complaint.

2nd.

That the said Greenberry Boyer left surviving him at the  
time of his death, a widow, Elizabeth Ann Boyer, and the  
following named children and heirs at law to whom  
the property above mentioned descended, subject to the rights  
of said widow, to-wit: a daughter Emma M., now the  
wife of Emory H. Beall, and who with her said  
husband, resides in the city of Baltimore; a daughter  
Alice B., formerly the wife of — Aubrey, the said  
Alice B. Aubrey being now a widow, residing in Frederick  
County, State of Maryland; a son Basil C. Boyer,  
whose wife's name is Elizabeth J. Boyer, and who, with  
his said wife is now a resident of Frederick County,  
Maryland; and a son John W. Boyer, your Complainant  
whose wife is Mary E. Boyer, both of whom reside in  
Montgomery County, State of Maryland. That all of  
said sons and daughters of the said Greenberry Boyer  
are adults above the age of twenty-one years.
