John W. Grimes. A witness of lawful age produced on the part of the Plaintiff, being duly sworn and examined viva voce deposes and says as follows:-

My name is John W. Grimes sometimes written Grimer, my age is 27 years, I live in Frederick County, I know the parties to this Suit, and am one of the defendants. I knew Mr. McBride the deceased Plaintiff in this case. He was my uncle. He is dead. He died last fall at Monticome Hospital in this County, and left no will. He left no personal property worth mentioning and no administration was granted to any one.

His personal property was not sufficient to pay his funeral expenses. He left a small tract and lot of about 2 1/2 acres which are described in the exhibit filed in this case. The real Estate is worth about \$150 - more or less.
