This deed made this 18th day of October in the year Eighteen Hundred and eighty two by and between George J. Brown of Washington County, Maryland, and Martin L. Brown and Mary L. Brown his wife, Geo. W. Delanter and Isabella Delanter his wife, Martin L. Brown and his wife, Mary E. Brown, Wm. P. Young and Elizabeth Brown his wife, Henry F. L. Stottenger and Martha E. Stottenger his wife, and Mary Jane Brown all of Frederick County, Maryland excepting Geo. J. Brown and Mary L. Brown being of Washington County, Maryland, for and in consideration of the sum of Seventeen Hundred and fifty five Dollars (\$1755.) the said George J. Brown and Martin L. Brown in pursuance of the authority to us given by the said Geo. J. Brown and Mary L. Brown, his wife, Geo. W. Delanter and Isabella Delanter his wife, Martin L. Brown and Mary E. Brown his wife, Wm. P. Young and Cornelia A. Young his wife, Hezekiah T. Brown and Elizabeth Brown his wife, Henry F. L. Stottenger, and Mary E. Stottenger his wife, and Mary Jane Brown for the purpose by a certain power of Attorney dated on the 18th day of February in the year A. D. 1880, and recorded February 25th, 1880, in Liber A. F. No. 1, folio 270 ve., one of the Land Records of Frederick County, Maryland, as grant unto Joseph B. Brown, all that parcel of ground and being known as Lots No. 10, 11, 14, 15 & 16 on Plan of whole tract, and they being also part of an original tract of Land called "Fox Range" located in Harmon District Frederick County, Maryland, and which is described as follows: Beginning for the same at the end of the third line of Wm.
