To the Honorable the Judge of the Circuit Court for
Frederick County, Sitting as a Court of Equity: -

The Bill of Complaint of W. H. Fette, trading as W. H.
Fette & Bros. of Brunswick, Frederick County, Maryland, on behalf of
himself as well as a other creditors of Moses Brooke who
may come in and contribute to the costs and expenses of this
proceeding, respectfully shew unto your Honor: -

First: That Moses Brooke was in his life, and at the
time of his death seized and possessed of a certain piece
or parcel of land situated in the County of Frederick, State of
Maryland, which was conveyed unto him by deed from Samuel
Black and wife, dated January 12, 1870, and recorded in Liber
L. M. W. H. Folio 479, one of the Land Records of Frederick County,
as will more fully appear by reference to a Certified Copy of said
deed filed herewith and marked "Exhibit A" which, together with
all other exhibits herewith filed, it is prayed may be taken and
considered as a part of this bill of Complaint.

Second: That the said Moses Brooke was at the time of
his death indebted unto your complainant the said C. H. Fette, trading
as C. H. Fette & Bros. in the sum of Forty-four Dollars and ninety
Cents (\$44.90) for services rendered and for matters and things
properly chargeable on account, evidenced by his duly sworn account
which is filed herewith as a part hereof and marked "Exhibit B"

Third: That the said Moses Brooke, being indebted as aforesaid,
departed this life on or about the 18th day of September, A. D. 1912,
leaving surviving him the following heirs at law, to wit: - Mary Ellen
Brooke, a sister, who is now an inmate of Montross, Frederick County,
Maryland; James Brooke, a brother, whose whereabouts are unknown;
Lida Snowden, a sister, who is a widow and lives in Puchette, State
of New York; and the following children of Charles Brooke, a brother,
who died intestate prior to the death of the said Moses Brooke,
to wit: - James Brooke, a son, whose wife's name is Susan Brooke
Marshall Brooke, a son, whose wife's name is Ida Brooke, all
