1. Your Orators, complaining sat--

Norris, his wife, and Harry E. Norris, and Elizabeth J. Norris, his wife, who are residents of the State of Ohio.

2. That Joseph M. F. Norris and Martin Luther Norris, his brother, both residents of Frederick County, Maryland, were seized and possessed of a certain parcel of real estate containing one acre of land located at Rocky Ridge, Frederick County, Maryland, and being the same real estate as described in the deed from William A. Black and Harry N. Black, to Joseph M. F. Norris and Martin Luther Norris, dated April 9th 1897, and recorded in liber J. L. J. No. 16, folio 185 one of the land records of Frederick County Maryland, a duly certified copy of which said deed is herewith filed as a part hereof and marked Exhibit A.

3. That the said Martin Luther Norris died intestate on the date January 13th, 1901, leaving surviving him as his next of kin and heirs at law, a brother your orator, Joseph F. M. Norris, a sister, Your oratrix, Elizabeth J. Geiselman, who is married to George K. Geiselman, Effie Rowe, who is married to F. Frank Rowe, Harry E. Norris who is married to Elizabeth J. Norris, and Vincent C. Norris who is married to Maud M. Norris, who are the three children of Joshua H. Norris, who was a brother of said Martin Luther Norris; William A. Black who married Marie Black, Harry N. Black who married Nellie A. Black, Howard J. Black, Daisy Valentine, who married Ira J. Valentine, Edith E. C. Black and Lula M. Baumgarten, who is married to John W. Baumgarten, who are the six children of Matilda Black, who was a sister of said Martin Luther Norris; W. Lee Norris and Grace Norris Ranneburg, who is married to F. Philip Ranneberg, who are the two children of John L. Norris, who was a brother of said Martin Luther Norris; and Nettie Norris Jernegan who is married to Warren G. Jernegan, and Mearl G. Norris, who is married to Alvia Norris, who are the children of George Washington Norris, who was a brother of said Martin Luther Norris.
