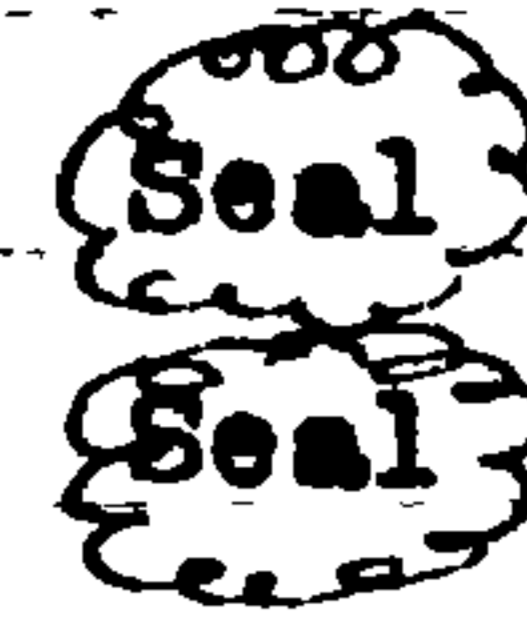

Gernand do grant unto Josiah Betts, of said County, all that piece of land situated in said county the same being part of a tract of land called "More Stones Added" and containig 13 5/8 acres of land, more or less being the same piece of land which conveyed unto the said Daniel U. Gernand by the said Josiah Betts as acting executor of Samuel Betts late of Frederick County, deceased, by deed bearing even date with this deed in which said piece of land is more fully described.
