

b. That the said Henry Hanson Maulsby Trustee as aforesaid, may answer as well the matters and things set forth in the original Bill of Complaint, as in this amended Bill.

c. That your Orators may have such relief against the said Henry Hanson Maulsby as is prayed in the original Bill of Complaint against the Defendants therein named. May it please your Honors to grant unto your Orators the writ of sub-poena against the said Henry Hanson Maulsby Trustee of Jehu F. Eisenhauer in No. 6369. Equity, commanding him to appear on some day certain to be named therein, in this Court to answer the premises, and abide by and perform such decree as may be passed therein.
