

a defendant in the case myself I knew Adam Warrenfeltz in his lifetime he is dead now, he died in the year 1903, He died without a will, He left surviving him as his heirs at law the following children all of whom are adults Flora Schroeder, a daughter whose husbands name is Frank Schroeder they live at Ailington, Baltimore County, Maryland, a daughter Stella S. Plumer whose husbands name is Henry E. Plumer, they live near Hagerstown, Washington County, Maryland, a son Marshall H. Warrenfeltz whose wifes name is Virgie Warrenfeltz they live near Myersville this County; a daughter Mary L. Stockslager whose husbands name is Luther Stockslager they live near Waynesboro but in Washington County, Maryland, and myself-my mother died in 1902 then there is another sister also aduher daughter of Adam Warrenfeltz, whose name is Ciera E. Brinham whose husbands name is Robert Brinham she lives at Hagerstown but I dont know where Robert Brinham is he dont live with his wife, These are the six children of Adam Warrenfeltz who survived him, None are dead, and there were but us six children. My Father Adam Warrenfeltz, at the time of his death owned one piece of land of about 6 1/4 acres situated in Frederick County, Maryland. I look at Exhibit "A" to the bill of complaint, it is a certified copy of the deed for said land and correctly describes it. Adam Warrenfeltz also at one time owned a tract of land of about 8 acres of land in Frederick County, which is described correctly in the certified copy of the deed from him to myself (Written in the deed as Addison P. Warrenfeltz) My brother Marshall and my sister Ciera E. who at that time was married to a man named Chance who died and she aftward married Robert Brinham, this copy of the deed is filed in this case as Exhibit "C" on the 11th day of September 1914 I bought from my Brother Marshall Warrenfeltz his interest in this land and paid him one hundred and fifty dollars (\$150.00) for it; and on the latter part of July or early in August 1914 I bought the interest of my sister Cierra Brinham in this land and paid her Three Hundred dollars (\$300.00) for it; and they gave me the paper writing purporting to be a deed for their shares in said land, a certified copy of which is herewith filed with the Bill of Complaint and is marked Exhibit "E". These two parcels or tracts of land lie alongside of each other but they are not capable of being divided without loss and injury, there is but one set of buildings on it except an old house on the six acre tract and a log stable both in bad repair. The only way I see to antangle the whole thing is to sell it and devide the proceeds, I paid a mortgage on the six acre tract held by John O. Hays for two Hundred Dollars, and I had been paying the interest on the mortgage for about 20 years Father was paralyzed and couldnt work for several years before his death, I also paid the taxes on it, In my opinion this property is worth in the neighborhood of \$500.00 or \$600.00.
