My name is Walter C.Doty. I am in the stock business, and live in Jefferson, Frederick County, Md. I am forty-five years old, and I have known the parties to this cause all my life. I knew old Mrs. Boyer during her lifetime, and know that she died some time last spring. I think it was in May.

At the time of her death, she owned a residence property in Jefferson, which she acquired from the Whip heirs. I look at Exhibit A. It is a certified copy of the Deed from Paul Whipp, Ether L. Whipp and G. Presten Whipp, by Lettie M. Whipp, and it correctly descri bes the property in question. Mrs. Boyer left surviving her as her children and heirs at law Albert A. Boyer, whose wife's name is Virginia; Carrie Boyèns, who married Stephen Bowlus; Will Boyer, whose wife's name is Salome Boyer; Emory E. another son, whose wife's name is Carriev. Boyer; Florence Beachley, a daughter, who intermarried with D. Carlton Beachley; Lora Boyer, a daughter, who is unmarried; Russell L. Boyer, a son, whose wife's name i is Bessie; Etta M. Coblents, who intermerries with Oliver Z. Coblents, There is another son, Charles, who has been absent and unheard of for a matter of two years. I have heard rumore of his being married, but I do not know whether they are true or not. I never saw his wife, and it is only a matter of rumor that he is married. Mrs. Boyer died without leaving a Will, to the beast of my knowledge and belief. This property in Jefferson is not capable of being divided among the parties entitled thereto, without great loss and injury, and in my judgment it would be for the benefit and advantage of everybody interested that the property be sold, and the proceeds therefrom divided, under the Direction of the Court. In my judgment, it will sell at public sale somewhere around \$2000.

being duly sworn and examined, deposes and says as follows:-

My name is Oliver Z. Coblents. I live near Middletown, Frederick County, Maryland, and am a farmer. I am fifty-siz years old, and know all the parties to this cause. My wife was a daughter of Martha M. Boyer, deceased. Martha M. Boyer, who is mentioned in the Bill of Complaint, is dead, having departed this life last May. She left surviving her as her ohildren and heirs at law a son, Albert H. Boyer, whose wife's name is Virginia; Carrie Bowlus, a daughter, who intermarried with one Stephen R. Bowlus; William E. Boyer, a son, whose wife's name is Salome Boyer; Emory Boyer, another son, whose wife's name is Carrie V. Boyer; Florence Beachley, who intermarried with D. Carlton Beachley, Laura Boyer, an unmarried daughter; Russell L. Boyer, a son, whose wife's name is Bessie Boyer; my wife, Ettie M.Coblentz, and Charles W.Boyer, a son, who has been absent and unheard of for a period of two years. We have heard rumors of his having married, but whether he is nor not I do not know. He left this community very suddenly, and for no appearent cause or reason and none of the family have heard of his since he took his departure. Martha M. Boyer left no will that I ever heard of and to the best of my knowledge, she died intestate .
