is now handed me. It is a certified copy of a deed from Paul C. Whipp, et al. to the said Martha M. Boyer, and it correctly describes the property mentioned in the Bill of Complaint. This property, in my judgment, is not susceptible of division among the heirs of the said Martha M. Boyer as it stands now, without great loss and injury, and it would be necessary, in my judgment, and for the benefit and advantage of all parties conserned, that this property be sold under the direction of the Court, and the proceeds be divided among the parties entitled thereto. I believe this property ought to being at Public Sale, between \$2,000 and \$2500. To the general interrogatory.

Boyer during her lifetime. She died during the month of May last, and left survivinh her as her children and heirs at law Albert A. Boyer, whose wife's name is Virginia Boyer; Carrie Bowlus, who intermarried with one Stephen R. Bowlus; William E. Boyer, whose wife's name is Salome Boyerp Emory E. Boyer, whose wife's name is Carrie V. BoyerpFlorence Beachley, who intermarried with Carlton D. Beachley; Lora Boyer, who is ummarried; Russell L. Boyer, whose wife's nams is Bessie Bpyer; Ettie M. Coblentz, who intermarried with Oliver Z.Coblentz, and Charles W.Boyer. All these parties live in Frederick County, and most of them live near Jefferson. Charles W. Boyer left this community about two years ago, and has been absent and unheard of sinct that time. There were some rumors as to his being married, but whether they are true ar not I do not know.
