property which consists of a house and lot at 128 E. Fourth Street, in Frederick City, Maryland.

- 17. Do you still own 4t?
- A. Yes, sir.
- 18. Just state the circumstances under which the lots mentioned in these proceedings, loaced on Hamilton Avenue, were purchased.
  - A. He said he was going down to try to get some of the lots. I told him to go shaad and I would give him the money gor them and they were to be bought in a joint deed, to be mine at his death and at my death. After I had told him that, he went and bought the lots. If Et hadn't given him the money to have the lots, he couldn't have purchased them. He went down to buy the lots on my say so, and if it had been necessary for him to have had the money that very day the bid was made on the lots, I would have given it to him that day, but I told him if he bought the lots not to go over \$400. if they would have to be paid for immediately. The bid was made im November and they were to be paid for in April.

- 19. How much money did your husband have of his own at the time of making the bid upon these lotd?
- A, He had only about \$25. of his own when he made the bid and I don't suppose he would have that Much.
- 20. How much did he pay upon the lots the day they were sold?
- A. \$100.00.
- 21. Do you know where he got that money from?
- A. No, sir. All I saw was the \$25. If he had it, I didn't see it.
- 22. State whether or not you furnished the money with which to pay the remainder of the purchase price of the lots and if so, where it came from and when you got it.
  - A. I gave him the money the day I took it out pf the Bank. I had \$20. in gold and the remainder I had gotten from the rent of my house. The \$20. I had earned at the hosiery before I was married
- 23. Look at the check now shown you, marked Exhibit "Check", filed in this case, and state if that is your signature and if you drew that amount of money from the bank on the date of that check?
  - A. I positively did and that is positively my signature.
- 24. Look at the bank book now shown you, marked exhibit "F Deposit Book, No. 3039C, and state if that is the bank book by which you had the money deposited in the Citizens National Bank?
  - A. Yes, sir. It is the Book.
- 25. What was the total amount of the money that you invested in these lots?
  - A. It was \$300; it was made up of what I had in the bank and the \$20. in gold and the remainder the rent from my house.
- 26. At the time your husband paid for these lots, state whether or not, he had any money of his own?

  (Excepted as to leading and generally.)
  - A. No, sir. He didn't have any money of his own.
- 27. When did you first learn that the deed for these lots in question was made out in the name of your husband alone?
  - A. When it was brought to me. I sent for it and Mr. Isaiah Loy brought it up to the stere. I asked Mr. Groff and him, and he got it up to me.
- 28. Look at the paper now shown meu marked, Exhibit "D" andstate if that is a copy of the deed which your husband got for the lots in question in this case?
- A. Yesmsir,
- 29. Please state where you gave your husband the sum of \$300. which you testified to and upon what date, as near as you can recollect.
  - 1. I gave it to him the very day I drew it from the bank, at my residence up, stairs in my room at 130 E. Fourth St. in Frederick.
- 30. Was any one else present at the time,
- A. No, sir, there was not, (CROSS EXAMINATION.
