- 5. Look at the Bank book, marked Exhibit "3039C, and state if that is a correct copy of the ledger containing her account in your Bank?

Mrs. Annie Hoffman, a witness of lawful age, produced on the part of the Plaintiff, having first been duly sworn and examined, deposes and says as follows;-

- 1. Please state your name, age and residence.
- A. Mrs. Annie Hoffman; 152 East South Street, Frederick, Maryland; 47 years of age.
- 2. Did you know Mr. Thomas Hickman, who was the husband of Mrs. Gertrude E. Hickman?
- A. I have known him for the last twelve or fourteen years.
- 3. Do you recollect the occasion in or about the time he purchased some lots of Hamilton Avenue?
- A. Yes, sir.
- 4. Did you have any conversation with him if or about that time, and if so, state what was said by him?
- A. He came around one morning and stopped, and I congratulated him on buying the lots And he said "Don't congratulate me; give it to Gertie"-they were both owners of the lots. He said they were bought more particulary for her tham him, and that she had more money in them than he did.

- It was on the night he bought the lots, in Mrs.Rickett's store on E.Fourth Street. He showed me the papers for the lots and I was congratulating him on buying them, and he said I was to be congratulated him alone; that if hadn't heen for Mrs.Gertie he couldn't have gotten them.
- Did you have any other conversation with him; if so, state what was said with regard to the lots.
 - On one eccasion at my house he stood on the porch, and I asked him what he intended to do with regard to the lots, and he said that he and Gebtie intended to remove their home from Fourth Street out there and to build a home on one of the lots and the other lots there were going to put out in truck.
