
Sixth, That your oratrices and orators and defendants are adults above the age of twenty one years. To the end, therefore.

- (1) That a decree may be passed for the sale of said real estate.
- (2) That the proceeds of said sale may be distributed among your oratrices and orators and the defendants according to their respective rights and interests therein. (3) That your oratrices and orators may have such other and further relief as their case may require. May it please Your Honors to grant unto yoru oratrices and orators the order of publication giving notice to the said Charles B. Allison and Mary Catharine Allison, his wife, residing in New Bedford, State of Massachusetts, who are mon-residents of this State, of the object and substance of this bill, and warning them to appear in this Court, in person or by solicitor, on or before a certain day to be named therein, to show cause, if any they have, why a decree ought not to be pas as prayed; and also the writ of sub-poens directed to the said Ella M. Birely and William F. Bire; y. her husband, residents of Frederick County, State of Maryland, commending them and each of them; to be and appear, either in person or by solicitor, in this Court, on or before a certain day to be named therein, to show cause, if any they have, whys decree ought not to pass as prayed.
