This Indenture made this 22nd day of April in the year 1851, by and between Daniel Reeder of Frederlok County, State of Maryland, of the One part, and Issao Michael of the County and State aforesaid of the Other part WITNESSETH! - That whereas the said Daniel Reeder, by his sealed note, dated the 14th, day of April 1847, payable ten days after date, with interest, for the sum of forty three dollars and forty nine cents, by his other sealed note, dated on the 20th day of May 1848, for Sixty six dollars and forty four cents, with interest, and by his other sealed notes, with-interest, each of the sum of Ninety four dollars and seventy five cents, all dated first of April 1850, payable at three sin and nine months, with interest, the interest on all the above notes being paid until April first, 1851, stands indebted to the said Isaac Michael, in the sums named therein, and for the purpose of securing the payment of the said several noves together with all interest due thereon, the said Daniel Reeder doth agree to execute these presents, Now this Indenture Witnesseth, that the said Daniel Reeder for and in consideration of the above recited premises, as also of the further sum of five dollars, to him in hand paid, by the said Isaac Michael at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged hath granted bargained, sold, aliened enfoeffed released, conveyed and confirmed, and by these presents doth grant, bargain, alien and enfectfed, convey and confi irm, unto the said Isaac Michael his heirs and assigns forever, all those pieces or parts of parcels of tracts of land situate lying and being in the County and State aforesaid, aslled "Well Intended" and containing One and a quarter acres of land, more or less, adjoining the lands of Mathias Ahalt, Joseph L. Huffer and Isaac Michael, and now in the occupancy of the said Daniel Reeder, and being the same piece of land heretofore sold, said Daniel Reeder, by the said Isaac Michael, and by Benjamin Ramsburg, and the said Daniel Reeder doth alien, bargain, sell, convey, assign, transfer and make over unto the said Daniel Reeder, right, title, interest, property and estate of, in, and to the crop of wheat; now growing on the farm of Isaac Michael, also to one bay mare, and Colt, One Sorrel Mare, and Colt, One gray Mare, one wagon, one Bar-Shear Plow, one harrow, three shovel plows, two Cows, two heifers, Ten Shoat One sow and Pigs, One Cuppoard, two beds and bedding, Carpets, Tables, six Chairs, One Rocking Chair, and a Mare named Nell, the said Articlesnow being in the possession of the said Daniel Reeder, To have and to hold the said pieces or parts, a parcels of tracts of land, and premises, above described with every of the appurtenances, unto the said Isaac Michael his heirs and assigns, forever, to have and to hold the goods Chattels and Personal Property and estate unto the said Isaac Michael his Executors administrators and assigns, Provided always and it is the true intent and meaning of these prese, nts and the parties hereunto, that if the said Daniel Reeder shall well and truly pay, unto the said Isaac Michael his executors, administrators, or assigns, the said several sealed Notes, with the interst thereon on before the first day of August in the year 1851, then these presents to be void, In tes timony whereof the said Daniel Reeder, has hereunto set his hand and seal this 22nd day of April in

the year Eighteen hundred and fifty One.
