To the Honorable the Judges of the Circuit Court for Frederick County, sitting as a Court of Equity. The petition of Minnie G. Heffner, hereinbefore appointed committee as trustee in this cause, respectfully shows unto your Honors:-

1st. That she has not qualified as trustee of the estate of Charles H. Heffner, by filing a Bond, as required by the decree of your honorable Court, passed on the 27 day of October, in the year 1916, and that since the passage of said decree your petitioner has become convinced that it is impracticable and undesirable for her alone to undertake to act as trustee of said estate, as she finds said estate and the affairs of the said Charles H. Heffner, so involved, complicated and requiring so much attention that she cannot undertake to act as trustee of said estate without the appointment and assistance of some suitable person as co-trustee thereof.

WHEREFORE your petitioner suggests to your Honors John S. Newman as a suitable person to be appointed co-trustee with her of the estate of Charles H. Heffner; and prays your Honors to appoint him as such. And for such further or other relief as the nature and equity of the case may require.

The foregoing petition having by the Court been read and considered, it is thereupon this 4th day of November, in the year Nineteen Hundred and Sixteen, by the Circuit Court for Frederick County, sitting as a court of Equity, adjudged and ordered that the appointment heretofore made on the 27th day of October, 1916, of Minnie G. Heffner as sole trustee of the estate of Charles H. Heffner, be and the same is hereby revoked and annulled; and it is further adjudged, ordered and decreed that Minnie G. Heffner and John S. Newman be and they are hereby appointed Trustees of the estate of the said Charles H. Heffner to take charge of said estate and to administer the same under the orders and direction of this Court; and it is further ordered that they before they proceed to act as such trustees they shall execute a bond to the State of Maryland, with good and sufficient security, to be approved by this Court, or the Clerk thereof, in the penalty of Three Thousand Dollars (\$3,000) conditioned that they as trustees of the estate of the said Charles H. Heffner will faithfully discharge their duties as such trustees, and deliver up all the property of the said Charles H. Heffner whenever they may be required by the order of the Court so to do; and it is further ordered that they, as trustees of the estate of the said Charles H. Heffner, return to this Court an inventory specifically setting forth all property, real and personal, belonging to the estate of the said Charles H. Heffner, and all cash in hand and in bank; and further that they shall render a full and particular account of their receipts of income and expenditures by them made for and on account of said estate, once in every two years, or oftener, if required by the Court.
