4. That Mary Elizabeth Storm be appointed Trustee to assign the judgement from Henry Hays Jacobs to "Mary E.Worman" to "Mary Elizabeth Storm and Mary Elizabeth Storm , guardian of Ruth M.Worman."
5. That Mary Elizabeth Storm be appointed Trustee to assign the Judgment from William H.Eaton and Sallie M.Eaton to "Mary E.Worman,Exs.of William J.Worman,dec," to "Mary Elizabeth Storm and Mary Elizabeth Storm,guardian of Ruth M.Worman".
6. That,Mary Elizabeth Storm be appointed Trustee to assign the judgment from David J.May to "Mary E.Worman Exs.of William J.Worman,dec."to" Mary Elizabeth Storm and Mary Elizabeth Storm,guardian of Ruth M.Worman."
