(3) That any and all cloud upon the title of the plaintiffs to said property by reason of the pretended interests of the defendants be removed by a decree of your Honorable Court . (4) That your Orators may have such other and further relief as their case may require.

And the plaitiff pray for the following process:

May it please your Honor to great unto your fremtors the order of publication giving notice to the said Lookwood C. Rines of the City of Washington in the District of Columbia, Mar-Va Development Company and the Interior Marble Quarry who are non residents of this State of the object and substance of this Bill, and warning them to appear in this Court, in person or by solicitor on or before scertain day to be named therein to show cause, if any they have, why a decree eught not to be passed as prayed. And as in duty, etc.
