WITNESSETH; That for and in consideration of the sum of Three Hundred Dollars, the said Robert D. Wilhide, and Agusta Wilhide, his wife, do grant unto J, Wesley Creager the following described mountain lot, situated South West of Mechanicstown, in Frederick County, Maryland, designated lot No, 4, in a division of land, made by John R, Reuzer, acting Executer, of the last Will and Testament of Joseph Wilhide, late of Frederick County, Maryland, dec'd, Beginning for the same at the end of a line, drawn S, 31° W, 24, 2 perches, from a Stone planted on the south west side of a tract of land, now owned by Frederick White, obtained from Jesiah Mesner and wife, deed dated Nov, 11th, 1868, and recorded in liber C.
