WITNESSETH; that in consideration of the sum of Five dollars. in hand paid, the receipt of which is hereby acknowledged, I, the said Jacob Ira Green do grant in fee simple unto J. Wesley Creager, of the county, and State aforesaid, the following mountain lots, Ist, all that mountain lot being part of a tract of land called the "Three Mill seats", situated, lying and being in the County, and State Aforesaid, containing $46\frac{1}{2}$ acres of land more or less, being the same land conveyed in a deed from James C. Harn and Annie M. Harn, his wife, bearing date Aug, 4th, 1902, and recorded in Liber D.H.H. No.15, folio 301, one of the land records of Frederick County. 2nd All that Mountainlot being part of "Gists Forrest" in said County, and State containing $57\frac{1}{2}$ Acres of land more or less, it being the same land conveyed in a deed bearing date March 25th. 1908. from Charles W. Haman. and Elsie M. Haman his wife, to Jacob I.
