WITNESSETH; that for and in consideration of the sum of two hundred and four dollars, and thirty Seven cents, the said J. Wesley Creager and Effie D. Creager his wife do grant in fee simple unto James Damuth the following described tract or parcel of land situated about one mile north of Thurmont in Mechanicstown District, Frederick County, Maryland.
