I Daniel Z, Padgett of Frederick County and State of Maryland, do hereby make, Ordain publish and declare, this as for and as my last will, and testament in manner and form following, to wit:-

I first propose declaring that all my personal Property in my possession or in my name is property I hold in common with my two sisters, Ida Virginia Padgett And Catherine Padgett Cromwell. and in the same I have One half interest and each of my sisters have a one fourth interest. and further that the Only property that I own in my own right is a house and lot in the village of Adamstown of said County, and state, and that alone absolutely.

After the payment of all my debts, and funeral expenses, I give, devise and bequeath as follows:-

I give devise to my sister Ruth A. Kreig, my said House, and lot situate in the village Adamstown, Maryland, for and during her natural life, and at her death to her children,

I Give and bequeath to my sister Ruth a Kreig, the sum of two thousand dollars absolutely,

I give and bequeath to my brother Robert H, Padgett the sum of Five Hundred Dollars, I give and bequeath to my nieces Mary Elizabeth Padgett, and Nellie Padgett, all and any indebtedness that may be owing, to me by their mother, at the time of my death

I give and bequeath to my niece Lucy E. Cromwell, the sum of One thousand dollars,

I give unto Dolly Brady niece of my deceased sister Margaret E, Brady the sum of Five hundred Dollars, to be paid, as my executrix may deem advisable,

All the rest and residue of my estate I give, devise and bequeath to my said sister Ida Virginia Padgett,

And lastly I do hereby constitute and appoint my said Sister Ida Virginia Padgett executrix of this my last will hereby revoking all former wills by me heretofore made ratifying and confirming this as and for my last will. and as I have entire confidence in my said Executrix, I desire that she shall be excused from giving Bond for the faithful performance of her duties, further than shall be required by law to secure the payment of all debts, and taxes and assessments properly chargeable upon my estate, after my decease.
