This Deed made this 19th, day of February in the year Eighteen hundred and Biety five by me Frederick W, Main, of Frederick City, frederick County, in the State of Maryland,

Witnesseth; that for and consideration of the premises and the sum of Fourteen Hundred (\$1400, 00) dollars, payment of which is hereby acknowledged, I, the said frederick W, Main, do sell grant and convey in fee simple, unto Suand Cordelia Blentlinger, of the aforesaid city, County and State, all that lot or parcel of land, with the buildings and improvements and appurtenances thereon or thereto belonging, situate lying and being on the south side of west Patriok Street in the aforesaid City, of Frederick and known as lot or part of lot of ground which was conveyed to me by deed fro Mary Snyder bearing date november 8th- A, D, 1875, and recorded in Liber T.G. No, 4, folio 166 one of the land Records of frederick County, and being also the same parcel or tract of Ground, which was devided to the said Mary Snyder by John snyderher husband, by his last will and testament. bearing date the 2nd day of September A, d. 1854, and recorded in will Records T.G. No. 1 folio 602, one of the will records of frederick County, to which reference will more fully appear
