My name is Thomas R. Myers; my age about 39 years and I reside in Liberty-town, Frederick County, Md,

I knew the Marcellus Beall mentioned in these proceedings, very well, he died on January 14-1919, at his home in Liberty town,

I Knew the town property and Farm of which the said Marcellus Beall died seized and Possessed and described in the Testimony of the preceding witness, which I have heard, and the Exhibits nos 2-3 correctly describes said Real Estate, I think The town Property is worth About \$1500. or \$1600, and the farm I think will bring about \$100, per acre, or more as it is situated on the South side of The Frederick Turnpike which is a Prospective State road,

The Said Marcellus Beall left a will of which a certified Copy is filed in this cause, as Exhibit No,1,

The widow renounced the provisions of the Will and I see by Exhibit A, To the testimony in this case, the Court has decided that the widow is vested with an undivided one third of the Real Estate, as heir, and the remaining 2/3 of the real estate is vested in the Nephews and Nieces, of the deceased,

I Knew Violet Irene Beall Irl Henry Beall and Lamora May Beall, who are the infant Children of Charles Henry Beall, a Brother, of the deceased Marcellus, They are of the nephews and Nieces of the deceased; but I am Not acquainted with the other Nephews and nieces who are the Children of May Alice (Beall) Ramsburg, a deceased, sister of Said Marcellus.

Said Real estate cannot be divided among the Widow and said Children Or Nephews and nieces, of Marcellus Beall, without loss and Injury, thereto, and I think the real estate, should be divided among these entitled, to take title,
