Dennis, Jr, of said County, who, in virtue thereof, has possessed, himself, of the said personal Estate, of the said Georgiana Ashby, as will fully appear by reference to a certified Copy of letters of Administration, granted on the estate of Said Georgiana Ashby, herewith filed as part hereof Marked Exhibit C,

6- That Your Petitioner, is informed and believes and so charges that said personal estate left by your intestate is not sufficient to discharge all the just debts, due and owing, by the said Testator, Georgianna Ashby at the time of her death, but they are advised, that the same now in the Hands of George R, Dennis Jr., ought to be applied to the payment of the Claim of Your Orator, and Other Creditors of the Said Georgianna Ashby, so far as the same will extend and That deficiency in said personal estate, ought to be applied by a sale of all or such part as may be necessary, of the real Estate of the Debtor, Aforesaid,

7, That the said Georgianna Ashby left surviving her as her only heir at law by her grand daughter, and adult non-resident, Georgia Price, who is unmarried and now resides, in the City of Philadelphia, Pennsylvania,

To The end therefore,

(1) That the real estate of the said Georgiana Ashby may be decreed to be to be sold for the payment of her debts, and,

(2) That your orator may have such other and further relief as the nature of his case may require,

May it please your Honors to grant unto your Orator the Order of Publication giving notice to the said Georgia Price of the State of Pennsylvania as aforesaid, who is a non-resident of this state, of the Object and Substance of this Bill, and warning them to be and appear in this Court, in person or by Solicitor, on or before a certain day, to be named therein, to Show cause, if any they have, why a decree ought not to pass as prayed,
