Deed,

At the request of Isaac Cronise the following deed was recorded June-14-1872

This Deed made this Fourteenth day of February, in the Year of our Lord, One Thousand, Eight hundred and Seventy two, by me William J, Worman, of Frederick County, in the State of Maryland, Witnesseth, that in Consideration of the sum of Seventy five dollars, I the said William J, Worman, do grant in fee simple unto Isaac Cronise, of said County, and State All that lot or parcel of land lying and being in Frederick County, in the State of Maryland, aforesaid and described as follows; Beginning at a point South 77° East 55 feet from a Stake planted in the Centre line of the road bed, of the Frederick and Pennsylvania line Rail Road, as the said road is now located and built, said stake being marked, 152x35 and being 35 feet North, of Station 152 of said Centre line, a d being near the boundary of the land of the said William J, worman, and the said Isaac Cronise, and running thence south 77° East 65 feet to the boundary of the Turnpike leading to Emmitsburg, thence with the Boundary of said Turnpike, South 2° West 220 feet thence North 80½° West 113 feet Thence North 15½ East 219 feet to the Place of Beginning, aforesaid containing one half of an Acre of land more or less, as sis lot or parcel of land is now enclosed, and fenced, it being part of the farm of William J, Worman,
