ORDER OF PUBLICATION

The object of this Bill is to procure a decree for the sale of certain real estate of or in the City of Frederick, Frederick County, Maryland, of Which Georgiana McDonald, died Seized and possessed, for the purpose of paying the debts of the said Georgianna McDonald, deceased,

The Bill states that at the time of her death the said Georgianna McDonald, deceased, was seized and possessed in fee simple, of a certain lot or parcel of Ground, situated, lying and being in the City of Frederick, Frederick County, State of Maryland, on the East side of North Bents Street, between Five and five and a half, and six, Streets, in said City, it being the same lot or parcel of ground, granted and conveyed by Harry R, Snook and wife, to the said Georgiana McDonald, by deed dated the 30th, of June A,D, 1913, and recorded in Liber H,W_B, no,306, folio 28- etc., one of the land records of Frederick County, and that at the time of her death, the said Georgiana, McDonald, was indebted unto Thomas P, Rice, in the sum of Forty-four dollars, (\$44,00) unto Charles S, Brooks, in the sum of Twenty-Five dollars, (\$25,00) and her estate is further indebted unto lewis B, Kehler, in the sum of \$50, 01. and that the said Georgianna McDonald, left no personal property, or estate, of any Character out of which to pay her debts, that the said Georgianna McDonald, deceased, left surviving her as heir at law, Mollie Danner, adult, of Springfield State of Ohio and a non-resident, of the State of Maryland, and a legatee under the will of said Georgianna McDonald, Widow, died in the City of Frederick on or about the 28th day of June A,D,1918, leaving a last will and Testament, which was filed for record on the 8th day of July A,D,1919, in the office of the Register of Wills for Frederick County,
