First and Principally, I commit my soul into the hands of Almighty God and my body to the earth to be decently buried at the direction of my Executor hereinafter named, and after my debts and funeral charges are paid and a monument erected to my memory at an expense not in excess of twenty five dollars and in addition to my name on said monument I would like to have that of my Aunt, Susan Stewart inscribed.

I devise and bequeath as follows;-

Item'- I give devise and bequeath to my sister Mary H. McElfresh and her husband Edmund W. McElfresh Sr, my one half interest in or thirty acres, in that tract or parcel of land, known as Canada Hill, situate in Urbana District, Frederick County, Maryland, for and during their natural life time and after their death, the same portion of land to be disposed of as hereinafter directed,
