TO THE HONORABLE, THE JUDGES OF SAID COURT; -

The Petition and Report of Sales of Edgar H. McBride, Assignee, respectfully represents unto your Honorable Court;

FIRST; That on the 29th day of March, 1920, a certain Benjamin F. Norwood and Mary A. Norwood, his wife, executed their deed of mortgage conveying certain real estate to the Commercial State Bank of Frederick, Maryland, to secure the payment of their promissory note bearing date of March 29, 1920, and payable to the order of said Bank, six months after date, said original mortgage being filed herewith marked "Exhibit No. 1" to this Petition and Report of Sales, the same being recorded in Liber No. 330, folio 236, one of the Land Records of Frederick County; which mortgage contained a provision that if the said Benjamin F. Norwood and Mary A. Norwood, his wife, should default in the payment of said
