EXHIBIT NO. "2" MORTGAGE

This Indenture, made the First day of November in the year of our Lord one thousand nine hundred and twenty-one, Between J. Stewart Annan, Edgar L. Annan and Andrew A. Horner, all of the town of Emmitsburg, in the Court of Frederick and State of Maryland, of the first part, And Annan, Horner & Company, of the same place, of the second part.

Whereas, the said J. Stewart Annan, Edgar L. Annan and Andrew A. Horner, trading as the Blue Mountain Orchard Company, have delivered unto Annan, Horner & Company, said party of the second part, their certain promissory note of amount, tenor, etc, as follows, to wit \$15,000.00 Emmitsburg, Md., Oct. 28th, 1921.

Ninety days after date we promise to pay to Annan, Horner & Co., or order at the Banking House of ANNAN, HORNER & Co., in Emmitsburg, Maryland, Fifteen Thousand; ;xx/100 Dollars

For value received, with interest from date an attorney's fee of five per cent., in case payment thereof shall not be made at maturity, hereby authorizing confession of judgment against us in favor of the holder for said sum of money and interest by any attorney of any Court of Record of the State of Maryland, if the same be not paid at maturity, with costs of suit, without stay of execution and with the waiver of the right of appeal and of the benefit of all exemption laws of the said State now in force.
