In the Circuit Court for Frederick County, sitting as a Court of Equity.

Martha E. Bradfield and James H. Bradfield, her husband vs George Rohr and HESSIE ROHR, his wife, Mrs. Florence Taylor widow, Stockton Sponseller and Julia A. Sponseller, his wife, Buchanan Sponseller and Lucy M. Sponseller, his wife, Mrs. Emma Learmont widow, Louise Miller and Ernest Miller, her husband, Mary H. Noobit and John R. Nosbitt, her husband, John M. Boulden and Elizabeth Boulden his wife, Christopher Boulden and Nettie Boulden, his wife, Margaret N. Snell and William Snell, her husband, Bessie Burns and \_\_\_\_\_ Burns, her husband, Mrs. Mary Howard, widow, Frank Sponseller, Nelson Sponseller and Mamie Sponseller, his wife, Null Sponseller and Isia Sponseller, his wife, Ola E. Alexander and \_\_\_\_\_ Alexander, her husband, John Sponseller widower, Mrs. Emma Lewis widow, and Oscar Glessen widower.

The object of this Bill is to procure a decree for the sale of the real estate of which Abraham Sponseller, late of Frederick County died, seized and possessed, which consists of a lot and house situated in Emmitsburg in Frederick County, State of Maryland, described in a deed from Michael Sponseller to the said Abraham Sponseller bearing date the 3rd day of Feb. 1828, and the Bill in substance states; That the said Abraham Sponseller of Emmitsburg in Frederick County, State of Maryland died on or about the 24th day of July 1849, intestate, leaving a widow Mary Sponseller who died on or about October 2nd. 1890 and the following children and heirs at law viz;

- A. A daughter Katherine who married \_\_\_\_\_ Rohr, both dead and died intestate leaving two children viz; a son George Rohr whose wife is HESSIE ROHR and a daughter Mrs. Florence Taylor now a widow and all reside in Baltimore, Maryland.
- B. A son Abraham who married \_\_\_\_\_ Sponseller, are both dead and died intestate leaving three children viz; a son, Stockton Sponseller whose wife's name is Julia A. Sponseller, a son Buchanan Sponseller whose wife's name is Lucy M. Sponseller and a daughter Mrs. Emma Learmont, now a widow all of whom reside near Bolivar in the State of West Virginia.
- C. A daughter Margarett who married \_\_\_\_\_ Boulden both of whom are dead and died intestate leaving six children viz; a daughter Martha E. who married James H. Bradfield both of whom reside in Baltimore, Maryland, a daughter Louse who married Ernest T. Miller both of whom reside in Chicago, Illinois, a daughter Mary H. who married John R. Nosbitt both of whom reside in Port Deposit, Maryland, a son John M. Boulden whose wife's name is Elizabeth both of whom reside at Bowers Creek in the State of Delaware, a son Christopher C. Boulden whose wife's name is Nettie both of whom reside in Philadelphia in the State of Pennsylvania, and a son William who married \_\_\_\_\_<sup>are</sup> both dead and died intestate leaving two children viz; a daughter Margaret who married William Snell, both reside in Baltimore, Maryland and a daughter Bessie who married \_\_\_\_\_ Burns both of whom reside in Perryville, Maryland
- D. A son, Joseph Sponseller who married, both dead and died intestate leaving five children viz; a daughter Mrs. Mary Howard now a widow, a son Frank Sponseller who married but now a widow, a son Nelson Sponseller whose wife's name is Mamie, a son Null Sponseller whose wife's name is Isai all of whom reside at Beaver Falls in the State of Pennsylvania and a daughter Ola who married \_\_\_\_\_ Alexander both of whom reside at New Barton in the State of Pennsylvania.
- E. A son Joseph Sponseller who married but his wife is dead and he resides at Ritzville in the State of Washington.
- F. A daughter Melissa who married John B. Glessen both of whom are dead and died intestate leaving two children viz; a daughter Mrs. Emma Lewis now a widow who resides in Fredonia in the State of New York and a son Oscar E. Glessen who married but his wife is dead and resides in Des Moines, Iowa, all of said children and grand children and heirs at law of said Abraham Sponseller are adults over the ty one years of age.
