This Deed made this Sixth day of April, in the year Eighteen Hundred & Ninety two by David A. Hershel of Frederick County in the State of Maryland. Witnesseth; that in consideration of Fifty Dollars, the said David A. Hershel do grant unto Barbara C. Hershel of said County all that parcel of land situated in said County the same being part of a tract of land called "Sweep Stakes" or "Long Ridge" being also the same land which was conveyed to the said David A. Hershel by Joseph Smith & Ann M. Smith his wife by a deed dated the 18th day of April A.D. 1881. Beginning of the said parcel of land intended to be conveyed at the beginning of said Smiths deed & running thence with the 1st line thereof, N. 65 1/2° W. 33 1/4 ps, to a stone, then S. 15° W. 9 3/4, S. 67° E. 7 18/20 ps, to a Walnut tree then S 10° W 8 4/20 ps, to intersect the 4th line of said Smiths Deed for said land, & with it S. 62 1/2° E. 24 1/4 ps. to the end thereof then with the 5th line thereof B 21° E 18 17/20 to the place of beginning, containing 3 1/4 acres of land more or less in fee simple.
