N. 33° E. 12 Ps. N. 36° W. 28 ps. S. 42° W. 28 ps. N. 38° W. 20 ps. S. 23° W. 16 ps. S. 62° E. 10 ps. S. 34° W. 6 ps. to a poplar tree then with a straight line to the place of beginning containing eight acres of land more or less in fee simple.
