Rutherford, as tenants in common being dated, February 8, 1906, and recorded in Liber S.T.H. No. 274, folio 39, one of the Land Records for Frederick.

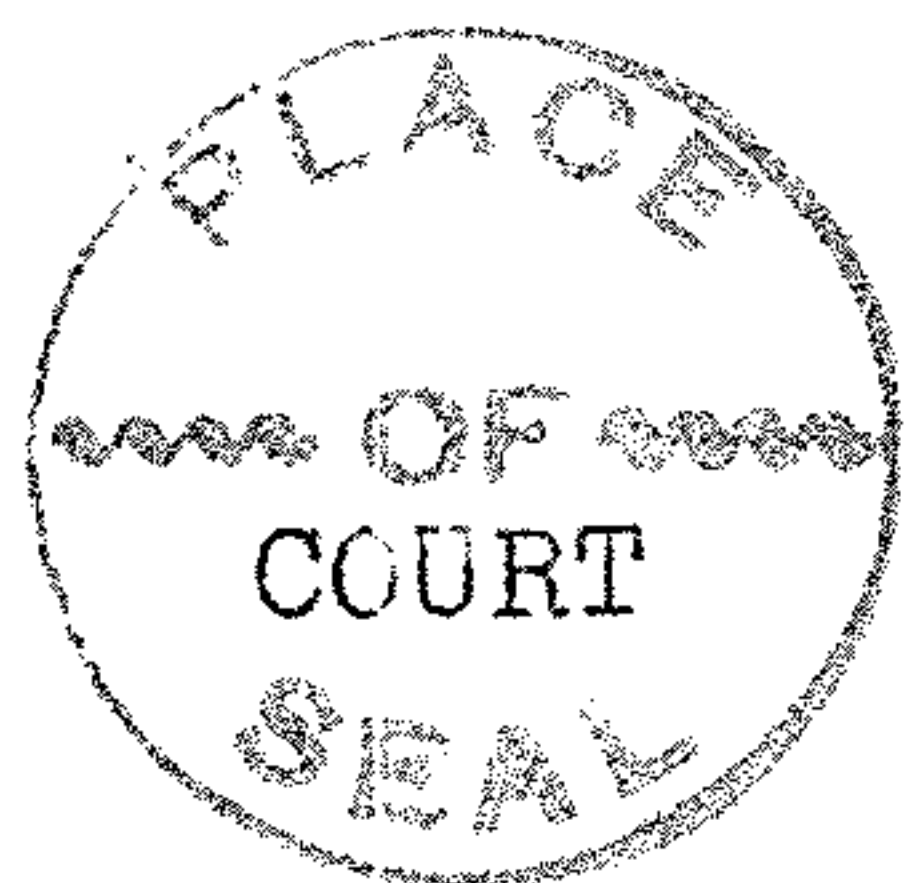
