2nd. That the name of the Corporation is "The Obenderfer Droneburg Company."

3rd. The purpose for which the Corporation is formed and the business or objects to be carried on and promoted by it are as follows: To Purchase Lease or otherwise acquire property, real personal and mixed, and to own, hold, sell and convey exchange, encumber by mortgage, or Deed of Trust, or other wise, deal in, utilize or dispose of such real, personal and mixed property and any rights, interest Equities, mortgages and options in, upon or affecting any property to buy manufacture, sell, deal in, and engage in, conduct and carry on the business of manufacturing, buying, selling and dealing in goods wares and merchandise, or every class and description and more especially to buy, sell deal in, conduct and carry on the business of buying, selling, dealing in household furniture, carpets, rugs stoves lamps, pictures, glass and wooden-ware of every class and description.

4. The principal office of said Corporation in the State of Maryland, will be located at 24-26 East Patrick Street, in the City of Frederick and County of Frederick, State of Maryland.

The name and address of the resident agent is J. Murray Dronenburg, Zentz Apartment, in Frederick City, State of Maryland, said agent being a Citizen of the State of Maryland and actually resides therein.

5. The aggregate of the Capital Stock of said Corporation is One Hundred Thousand dollars (\$100,000.00) and the Capital Stock divided into One Thousand shares of the parvalue of \$100.00

6. The said Corporation shall have three Directors and Frederick W. Obenderfer, J. Murray Droneburg and John W. Obenderfer shall act as such until the first annual meeting of the Corporation or until their successors are duly chosen and qualified.
