Obenderfer, upon the payment by him to said Receivers of the sum of Nineteen thousand, three hundred and ninety-eight and 15/100 Dollars (\$19,398.15), and the additional sum of money that may be sufficient or necessary to pay one hundred cents on the dollar of all the legitimate indebtedness of The Obenderfer-Dronenburg Company, a body corporate, including interest and the costs of this proceeding, including commissions and solicitor's fee, according to the terms of "Offer to Purchase" of Frederick W.
