This Deed made this Third day of June in the year Eighteen hundred and ninety five by Benjamin Shuff of the County of Frederick and State of Maryland, Witnesseth, that in consideration of Twenty dollars said Shuf doth sell unto James O. Harne of same County and State, all that parcel of land situated in said County the same being part of of a tract of land called Bruces Range and part of a tract called Stony Lick begining for the part hereby intended to be conveyed at the end of $8\frac{1}{2}$ ps. on the given line of the part called Stony Lick and running thence with the 2d line of Harne & Delauters part of said land reversed N. 3° W. 56 ps. N. 15° E. 6 ps. to a large white oak tree on the East side of the public road then S. $84\frac{1}{2}^{\circ}$ E. 36 ps., S. 9° W. 24 ps., S. 30° W. 38 ps. then S. 82° W. $4\frac{1}{2}$ ps. then with the given line of Stony Lick S. 60° W. $8\frac{1}{2}$ ps. to the place of beginning, containing $9\frac{3}{8}$ acres of land more or less, the same being Lot No. 8 of Plat B. of the land as sold B. Peter H. and Martin T. Bussard, Trustees. Witness my hand and seal.

This Deed made ninth day of July in the year Eighteen hundred and Eighty Eight, by Cyrus C. Shuff and his wife Sarah A. Shuff of Frederick County in the State of Maryland. Witnesseth that for and in consideration of fifteen dollars, the said Cyrus C. Shuff and his wife Sarah Alice do grant unto James O. Harne of said County all that piece of land situated in said County the same being part of a tract of land called Hide and Seek being also the same piece of land which was conveyed unto the said Cyrus C. Shuff by Frederick A. Stotemyer and wife by deed dated Mar. 25, 1887 being also the same piece of land which was conveyed unto the said Frederick A. Stotemyer by "The Catoclin Iron Company" by deed dated Oct. 10th
