

In the event that I shall not erect a footstone at my grave I hereby authorize and empower my executor to erect a footstone at my grave on the Castle Lot in Mt. In the event that I shall not have disposed of my real estate, I hereby authorized and empower my executor to make sale of, and convey any parcel or parcels of real estate, of which I may die, seized and possessed, and the proceeds of this sale to become part of the residue of my estate.

All the rest and residue of my estate I give, devise and bequeath as follows:

One-third of the rest and residue of my estate to Charles Halley.

One-third of the rest and residue of my estate to Bradley T. Halley.

One-third of the rest and residue of my estate to the children of Edward M. Halley, the names of said children being Mrs. Louise M. Shelly, Mrs. Elizabeth Depro, Mrs. Nan C. Rodda, David A. Halley, Frank P. Halley, and Edward M. Halley, the one-third to be divided among said children.

And lastly, I nominate, constitute and appoint Joseph W. L. Carty, of Frederick City, Maryland, to be the executor of this my last will and testament, hereby revoking all former wills by me heretofore made, and declaring this and none other to be my true last will and testament, and I declare that my said executor shall not be required to give bond for the faithful performance of his duties in the settlement of my estate.
