To The Honorable, the Judges of said Court:

The petition of Edgar Bartlett and Annie Bartlett, his wife, et al. complainants in this cause, respectfully represents unto Your Honors:

1. That the defendants, Alberta B. Stevens and Carrie Bartlett Davis, are both married women with husbands living and your petitioners believe it desirable that the husbands of said defendants be jointed as co-defendants in this cause.
2. That the husband of the said Alberta B. Stevens is V. Augustus Stevens, a resident of Frederick County, Maryland, and the husband of the said Carrie Bartlett Davis is Samuel Davis, a non-resident of the State of Maryland residing in Loudoun County, Virginia.

Wherefore, your petitioners pray Your Honorable Court to pass an order giving your petitioners leave to amend the said Bill of Complaint by joining the said V. Augustus Stevens, husband of Alberta B. Stevens, and the said Samuel Davis, husband of Carrie Bartlett Davis, as defendants and that the original process prayed for in the Bill of Complaint be amended so as to grant to your complainants a writ of subpoena directed to the Sheriff of Frederick County, Maryland, as to the defendant, V. Augustus Stevens, and an Order of Publication as to the non-resident defendant, Samuel Davis.
