LAST WILL AND TESTAMENT

of

VICTORIA L. POOLE

IN THE NAME OF GOD, AMEN, -

I, Victoria L. Poole, of the County of Frederick, State of Maryland, being of sound and disposing mind, memory and understanding, do hereby make and publish this my last Will and Testament, in manner and form following, that is to say:-

1st ITEM:-First and Principally, I committ my soul into the hands of Almighty God, and my body to the earth, to be decent- buried, at the discretion of my Executor; and my will is, That all my just debts and funeral expenses shall be paid by my Executor, as soon after my decease as shall be convenient;-

2nd ITEM:- I give, devise and bequeath, in trust, unto G. Ellis Williams, of Frederick, Maryland, all my estate, real Personal and mixed to be held by him or invested safely for the benefit, maintenance and support of my son, George W. Poole, for and during his natural life. The said G. Ellis Williams, as my Executor and as said Trustee, shall have authority to sell and dispose of, at either public or private, sale, any portion of my estate so as to provide properly for the maintenance and support of my said son or, if in his judgment, said action is for the best intrest of my estate and the beneficiaries herein mentioned.

3rd ITEM:- Upon the death of my said son and the payment of all costs and expenses necessary to his proper maintenance and support and burial, I hereby give, devise and bequeath, and I hereby direct that my Executor and Trustee shall pay, unto the the Trustees of Calvary Methodist Episcopal Church, Frederick, Maryland, the sum of One Thousand Five Hundred Dollars (\$1,500).

4th ITEM:- I hereby give, devise and bequeath unto Mrs. Ida Pomeroy for the love, care and affection, she has bestowed upon me the sum of Five Hundred Dollars (\$500). If she pre-decease me, it is my wish that said sum be paid to her daughter, Mabel Dolores Pomeroy. If both of these pre-decease me, it is my wish that said sum be paid over to Marion F. Pomeroy.

5th ITEM:- I hereby direct that my Executor and Trustee give permission for the following interment on my lot in Mt. Olivet Cemetery: Marion F. Pomeroy, Ida Gertrude Pomeroy, and Mabel Dolores Pomeroy.

6th ITEM:- All the rest and residue of my estate I hereby give, devise and bequeath unto my nieces and Nephews, to-wit: Nelly Graham, Edward Beatty, Guy L. Nusz, Ira G. Nusz and Sally Snyder share and share alike.

7th AND LASTLY:- I hereby nominate, constitute, and appoint G. Ellis Williams to be the Executor of this My last Will and Testament, without bond and my Executor shall have authority to make sales of any portion of my estate without application to any Court.
