ORDER OF PUBLICATION

The object of this suit is to procure a decree for the sale of certain real property in Frederick County, State of Maryland, of which Martha A. Toms, deceased, late of Thurmont District, Frederick County, Maryland, died seized and possessed, for the use of M. L. Creager and Raymond D. Creager, trading as M. L. Creager and Son and for all other creditors of Martha A. Toms, who will come in and contribute to the expense of this suit.

The bill states that Martha A. Toms, late of Frederick County, Maryland died intestate, on or about the 17th day of September, 1937 and was seized and possessed of a tract or parcel of land situate about one mile north of Thurmont in Thurmont District, Frederick County, Maryland and being the same tract of land described in a deed from Charles M. Shipley and wife to John H. Toms, dated June 10, 1903 and recorded in Liber S. T. H. No. 265 folio 506 one of the land records of Frederick County, Maryland and also being the same tract or parcel of land as described in a deed from John H. Toms to Martha A. Toms, his wife, dated the 17th day of July, 1910 and duly recorded in Liber 342 folio 203 one of the land records of Frederick County, Maryland, excepting therefrom that tract of land conveyed by deed from John H. Toms and Martha A. Toms, his wife to Latimer T. Schildt dated July 10, 1907 and recorded in Liber S. T. H. No. 280 folio 446 &c. one of the land records of Frederick County, Maryland.

That the said John H. Toms, husband of the said Martha A. Toms, died on or about the 6th day of February, 1923 and upon the death of the said Martha A. Toms, intestate on or about the 17th day of September, 1937, she being seized and possessed of the real estate mentioned, which said real estate upon her death decended to and vested in her heirs-at-law and next-of-kin, as tenants in common, to wit the following parties:

Olive A. Recher, a daughter whose husband's name is John L. Recher, who reside near Thurmont, Frederick County, Maryland.

Brinton Toms, a son whose wife's name is Grace Toms, who reside at Thurmont, Frederick County, Maryland.

Rene Draper, a daughter whose husband's name is Clinton Draper, who reside at Midale, Sask., in the Dominion of Canada.

Dora Ridenour, widow, a daughter who resides at Smithsburg, Washington County, Maryland.

Olivia Myers, a daughter, whose husband's name is John Myers, who reside at Glen Cove, Baltimore County, Maryland.
