The Answer of Carrie C. Holtz, widow, to the Bill of Complaint filed against her and others in the above cause says:

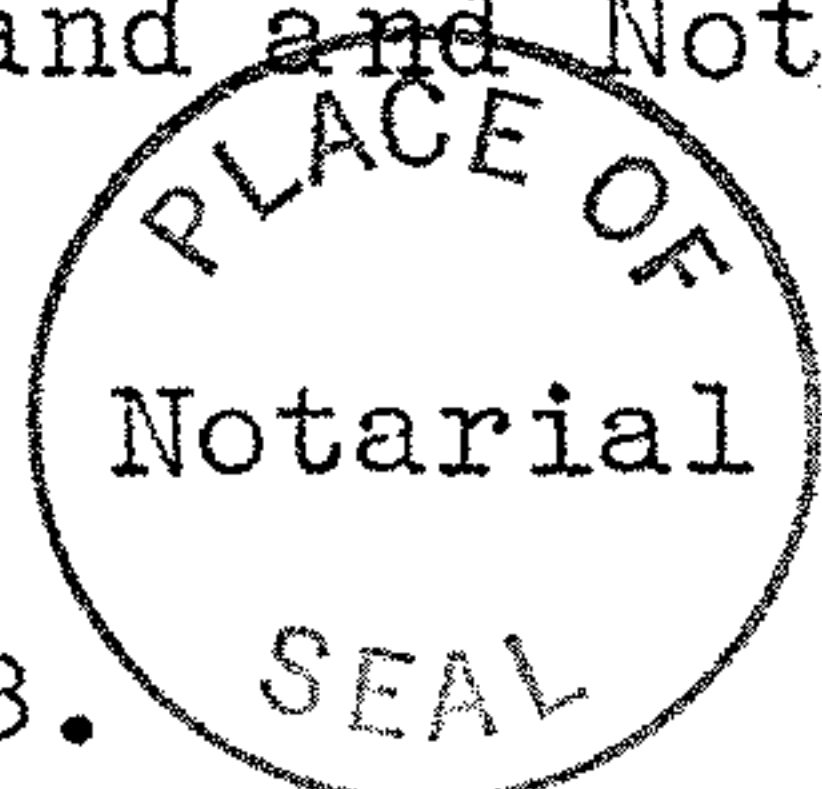
That she admits the matters and facts set out in said Bill of Complaint and consents to the passage of such decree as may be right and proper in the premises.
