

EXHIBIT WILL

I, George S. Allnutt, of Frederick County, State of Maryland, do hereby declare this instrument of writing to be my last will and testament.

After the payment of my just debts and funeral expenses, I give, devise and bequeath, all of my property, real and personal, and wheresoever the same may be situated, unto my wife, Elixabeth D. Allnutt of Frederick County, Maryland, for and during the term of her natural life, and after her death to my six children, all of Frederick County, Maryland, namely: William T. Allnutt, Georgia Allnutt, E. Elizabeth Allnutt, Mary Allnutt, Catherine V. Allnutt, and Frances E. Allnutt, in equal shares, absolutely.

I direct that my wife, the said Elizabeth D. Allnutt, shall have full power and authority to sell any or all of my property real and personal, at either public or private sale, without the previous order or subsewent ratification of the Orphan's Court for Frederick County. In the event she shall make sale of any or all of said real estate or personal property I direct that she shall invest the proceeds therefrom, the income from said proceeds to be and become the property of the said Elizabeth D. Allnutt, for and during the term of her natural life, and after her death the corpus of said proceeds shall be divided among my six children, hereinbefore named, share and share alike.

I firther direct that the child or children of any deceased child shall take the share its parents would have taken if living per stirpes and not per capita.

I hereby constitute and appoint my said wife, Elizabeth D. Allnutt executrix and my said son William T. Allnutt executor of this my last will and testament, and request that they be execused from the necessity of giving bond for the faithful performance of their duties. I firther direct that in the event either shall die prior to my death or during the administration of my estate, the survivor of them shall have full power to act as executrix or executor, as the case may be.
