THIS DEED made this 18th day of April in the year Eighteen hundred and Eighty five by Nicholas E. Norris and Fannie W. Norris his wife of Frederick County and State of Maryland -- Witnesseth that for and in consideration of the sum of Fifty two Dollars and three cents - the said Nicholas E. Norris and Fannie W. Norris his wife do grant unto Summerfield Bigers of aforesaid County and State, the following described piece or parcel of land situate lying and being in Frederick County Maryland being a part of that piece of land conveyed to Nicholas E. Norris by deed from the heirs of Nicholas Norris late of Frederick County deceased dated 21st day of June 1882 and recorded in Liber A. F. No. 5 folio 395, 396 &c., One of the Land Records of Frederick County -- Beginning for the outlines of said piece or parcel of land at the beginning of the 11th line of the original tract and running with said line S 75 $\frac{1}{2}$ ° W 16 1/20 ps. to a stone thence S. 22° E 14 ps. to a stone thence N. 31° E 19 9/10 ps. to the beginning. Containing one half acre and 31 square ps of land more or less.

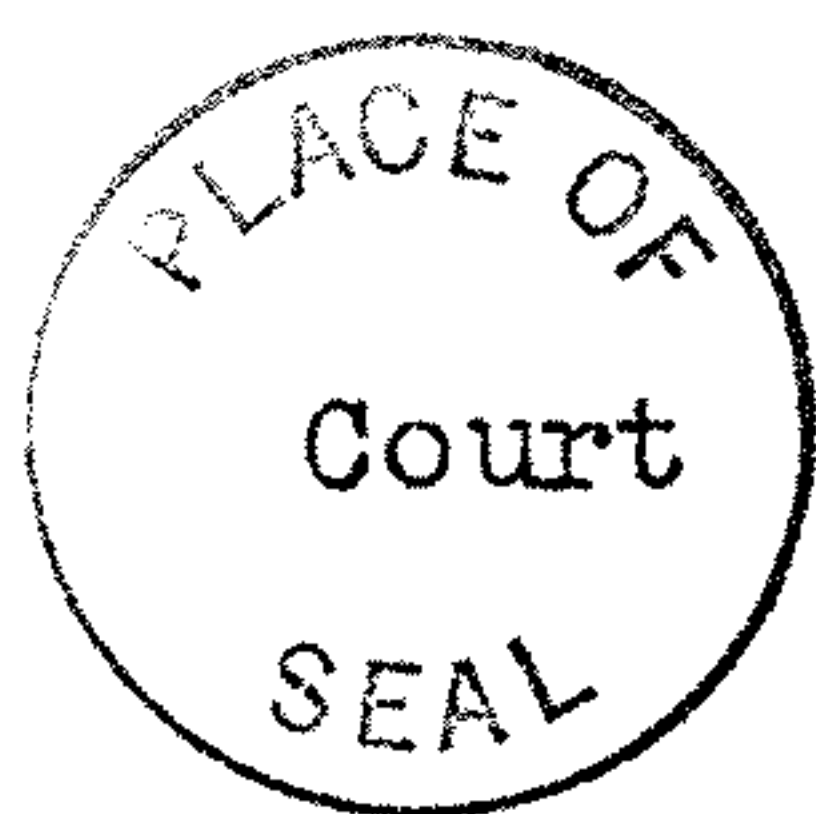
