TO THE HONORABLE JUDGES OF SAID COURT:

The Petition of Leo Weinberg, one of the Trustees in the above cause, respectfully shows:

FIRST: That by a Decree duly passed in this cause on April 20, 1939 the property mentioned in the proceedings were ordered to be sold, and Alban M. Wood and Leo Weinberg, Esquires, were appointed as Trustees to make said sale.

SECOND: That on May 11, 1939, the said Trustees gave their bond in the penalty of Four Thousand Dollars (\$4,000) as required by said Decree, with the New Amsterdam Casualty Company as surety, which said bond was duly approved by the Clerk of the Court.

THIRD: That since the passage of said Decree and the giving of the bond your Petitioner has been urging and entreating his associate, Alban M. Wood, Esq., to proceed with the advertisement of the property for sale, which said advertisement the said Alban M. Wood has frequently promised to submit to your Petitioner, but has never done so.

FOURTH: That the Decree having been passed nearly three months ago (exactly three months tomorrow, Thursday, July 20) your Petitioner now requests your Honorable Court to require the said Alban M. Wood, Esq., his associate Trustee, to proceed with the advertisement of said property for sale or in lieu thereof to authorize your Petitioner to do so, so that the said property may be disposed of by public sale as required by the Decree of the Court.

WHEREFORE, your Petitioner prays accordingly.
