3. That the Central Trust Company of Maryland qualified as Trustee under said will, and has been administering the several trusts created by said will, and now holds in its name, as Trustee, the farm hereinbefore referred to, which was conveyed to it by deed from Marion E. Ramsburg and Sara J. Ramsburg, his wife, to the Central Trust Company of Maryland, Trustee, by deed dated March 21, 1922, and duly recorded in Liber 338, Folio 203, one of the Land Records of Frederick County, and also holds in its name as Trustee 28 shares of Potomac Edison Seven Per Cent Preferred Stock herein before referred to and also there has been paid to the Receiver the sum of \$49.00, being the amount of accrued income in Receivers hands under the trust hereinbefore mentioned and described.

4. That the Central Trust Company of Maryland was placed in the hands of the Bank Commissioners of Maryland, on September 2, 1931, and is, therefore, no longer capable of acting as Trustee as aforesaid, under the will of Alexander Ramsburg, hereinbefore referred to, and it now becomes desirable and necessary to provide for the appointment of a substituted trustee to carry out the trust created by the will of Alexander Ramsburg hereinbefore referred to.

5. That it is the wish and desire of your Petitioners that Charles McC. Mathias be named as Substituted Trustee to administer and carry out the terms of the trust created by the will of Alexander Ramsburg hereinbefore referred to, and that the said Charles McC. Mathias has indicated his willingness to accept the appointment as said Trustee, as will appear by his certificate attached hereto and made a part hereof.

WHEREFORE your Petitioners pray that your Honorable Court may take cognizance of and assume jurisdiction of the trust created by the will of Alexander Ramsburg, referred to in this petition, and further that Charles McC. Mathias, be appointed as Substituted Trustee to administer the trust created by said will.
