

Likewise I give and bequeath unto the Central Trust Company of Maryland, Trustee, fifty-six (56) shares of the preferred capital stock of The Hagerstown and Frederick Railway Company, in trust that it will pay the income and profits arising therefrom unto my son, Luther Ramsburg, for and during the term of his natural life, and after his death then to his wife should she survive him, and after their death to be sold and distributed among their heirs per stirpes. In the event the said Luther Ramsburg and his wife, while occupying the aforesaid farm, shall fail to pay the taxes and make the necessary improvements thereon as herein provided, then I direct the said Central Trust Company to pay said taxes and make such improvements from time to time as may be necessary and deduct the same from the dividends received from the said fifty-six shares of preferred stock of The Hagerstown & Frederick Railway Company before paying the same to the said Luther Ramsburg or to his wife as hereinbefore provided.

In the event I should not have paid in full for the above mentioned farm prior to my death, then I will and direct that my Executrices hereinafter named shall do so.

All the rest and residue of my estate, after the same has been converted into money, I give and bequeath as follows:-

I give and bequeath unto each one of my daughters, Daisy Ramsburg, Dana Ramsburg and Mattie Ramsburg, the sum of One Thousand Dollars (\$1,000). I make them this bequest because of the long and faithful services which they have rendered to me and my wife.

I give and bequeath unto my Executrices hereinafter named the sum of Four Thousand Dollars, in trust that they shall invest the same and pay the interest and income received therefrom unto my wife, Hannah Ramsburg, for and during her life, and after her death the said sum is to become a part of the rest and residue of my estate, to be disposed of as hereinafter provided.

All the rest and residue of my estate I will and direct shall be divided into four equal parts or portions, and I give one of said equal parts to portions to each of my daughters, Daisy Ramsburg, Dana Ramsburg, Mattie Ramsburg, and Belle Getzendanner, wife of William R. Getzendanner. I have not included my son, Luther Ramsburg, in this last mentioned distribution for the reason that I have already advanced him large sums in my lifetime.

And lastly I hereby constitute and appoint my daughters, Daisy Ramsburg, Dana Ramsburg, and Mattie Ramsburg, to be the Executrices of this, my last will and testament, hereby revoking any and all former wills by me heretofore made and ratifying and confirming this and none other as and for my last will and Testament.

In testimony whereof I have hereunto set my hand and affixed my seal this 26th day of January, in the year nineteen Hundred and Twenty-two.
