Eighth: That all parties to this proceeding are adults.

Ninth: That a Partition of said property among the parties entitled thereto, according to the several interests therein as aforesaid, cannot be divided without loss or injury to the parties interested and that it would be to the best interest and advantage of all the said parties in interest that the property be sold under a Decree of your Honorable Court, and that the money accruing from said sale be divided among the said parties in interest according to their respective rights.

To the End therefore:

1. That a Decree may be passed for the sale of the real estate hereinbefore described under the direction of your Honorable Court by Trustee or Trustees to be appointed there under and that the proceeds thereof, may be distributed among the parties entitled according to their respective interests.

2. And that your Compliance may have such other and further relief as the nature and equity of the case may require.

May it please your Honorable Court to grant unto your Complainants the Writs of Subpoena directed to the said Benjamin F. Shreve, Carroll A. Shreve and Margaret Eula Fisk, adults, all residing at Dickerson, Montgomery County, Maryland, commanding them to be and appear in this Court at some certain day, to be named therein, and answer the premises and abide by and perform such decree as may be passed therein, and also the Order of Publication giving notice to the said Harry Fisk, an adult, of Washington, District of Columbia, who is a non-resident of this State, of the object and substance of this Bill and warning him to be and appear in this Court, in person or by Solicitors, on or before a certain day to be named therein, to show cause, if any he has, why the relief prayed for should not be granted.
