III. All that lot or parcel of land which was transferred by the Trustee in Equity Case No. 9081 in exchange for a part of William Waltman Wenner's land - said exchange being clearly shown by the Plat recorded in Liber S.T.H. at Folio 69. Deed recorded in Liber 308, Folio 373.

IV. All that lot or parcel of land which was conveyed to the B & F.R.R. Co. by deed recorded in Liber 336, Folio 344 - also shown on Plat mentioned in III, above, and in Equity case No. 9081.

V. All that lot of land conveyed by Deed recorded in Liber 276, Folio 3 to LeRoy B. Wenner, said land being 75,526.08 square feet of land lying between the South margin of the Public Road and the B & OR.R.'s north limits.

VI. The "School Lot" which was shown on the Plat of the "First Addition", the deed being recorded in Liber W.I.P. No. 13, Folio 368, conveying this lot to the Board of County School Commissioners.

VII. All that lot or parcel of land conveyed to Charles H. Feete by deed dated 7-13-1927 and recorded in Liber No. 362, Folio 543, being a parcel of land on the corner of Front Street and the Petersville Road, as shown on the plat of the "Second Addition".

VIII. All that lot or parcel of land which was deeded on 3-28-1900 to the County Commissioners by deed recorded in Liber D.H.H. No. 5, Folio 584, being the right of way for the Brunswick to Knoxville Road.

IX. All that lot or parcel of land conveyed by deed recorded in Liber No. 274, Folio 547, dated 6-1-1906, conveying 20.36 acre to the B & OR.R. Co., as per plat filed therewith.

X. All that lot or parcel of land as conveyed to John D. Ahalt by deed dated 1-29-1892 and recorded in Liber J.L.J. No. 1, Folio 442 - beginning at a point on the N.E. corner of the "Second Addition" and running N. along the Petersville Road 40 feet; thence W. on a line parallel with a street on the said Second Addition 75 feet; thence S. on a line parallel with the Petersville Road 40 feet to the line of a street on the N. side of said Second Addition; thence East along the line of said street to the beginning.
