

The foregoing Petition and Exhibits having been by the Court read and considered, it is thereupon, this 27th day of January, in the year Nineteen Hundred and Forty-three, by the Circuit Court for Frederick County, sitting as a Court of Equity, and by the authority thereof, adjudged and ordered that this Court does hereby assume jurisdiction of the Trust created by the Last Will and Testament of Grace W. Trail, deceased, for the use and benefit of her daughter, Grace Trail Babcock, mentioned and described in the foregoing Petition, and that the Clerk of the Circuit Court for Frederick County docket the case in the usual form;

And it is further ordered that the said Charles B. Trail and Charles McC. Mathias, the Trustees named in said Will, before entering upon their duties as such Trustees give corporate bond in the penalty of Ten Thousand Dollars (\$10,000.), conditioned upon the faithful performance of their duties in the execution of said Trust Estate, bond to be approved by the Court, or the Clerk thereof;

And it further ordered that the said Charles B. Trail and Charles McC. Mathias be and they are hereby authorized and directed to pay out of the fund referred to in said Petition the Clerk's taxes costs, and costs of securing bond, and that said Trustees shall proceed with the further administration of said Trust, subject to the further order of this Court.
