(G) That the said Thomas L. Danner left surviving him the following heirs by the first marriage of a brother, George T. Danner, whose first wife's name was Ida G. Danner, both the said George T. Danner and the said Ida G. Danner having predeceased the said Thomas L. (10) A daughter, Helen M. James, whose husband's name is Walter James, and whose last known address was 1507 Patterson Park Avenue, Baltimore, Maryland, but whose present address is unknown to your Complainant.

(H) That the said Thomas L. Danner left surviving him the following heir-at-law by a deceased brother, William Perry Danner, whose wife's name was Carrie Danner, both of whom predeceased the said Thomas L. Danner intestate, to-wit: A daughter, Lena M. Deaner, whose husband's name is Albert N. Deaner, and who resides at Knoxville, Frederick County, Maryland.

3. That all of the persons herein alleged to be heirs of Thomas L. Danner, late of Frederick County, Maryland, deceased, are adults over and above the age of twenty-one years.

4. That your Complainants have made diligent inquiry to ascertain and determine the names and residences of all the heirs of the late Thomas L. Danner, deceased, but after such inquiry it is not known to your Complainants as a positive fact that all such persons have been made parties to this proceeding and, therefore, respectfully urge that all such persons, and all persons herein alleged to be heirs of the said decedent whose present addresses are to your Complainants unknown, it being unknown whether or not such persons are at the present time residents of this State or non-residents thereof, may be proceeded against as the un-
